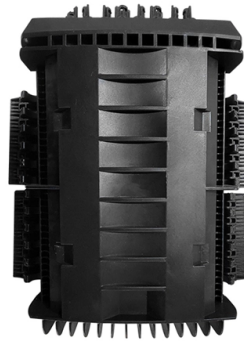


South African Indoor Optical Cable Equipment Standards
